Notes Rep	Caledonian Village parking issue is ongoing.  Gorgie Farm: The issue of LOVE encouraging people to set up direct debits for animal feed has been raised in neighbourhood groups. Love Learning is also not a registered charity. RM felt that the FAQs on EVOC website should be more explicit. MS confirmed that GDCC had had no further communication with EVOC. RM has raised with EVOC the need for better communication with the community.  Planning: RM is bringing a motion to Council requesting they write to the Scottish Government to request a review of the planning system with reference to unequal rights of appeal for communities and individuals. Planning Democracy and Friends of the Earth had complained to the UN because they believed this was an environmental injustice. RM will also raise the inaccessibility of the planning portal and lack of notifications. MS noted that users required expert knowledge to use the portal. Because people do not know how to correctly formulate objections, a lot of objections are disregarded. AM asked if the Council has undertaken any retrospective reviews of planning decisions. Notes	Gorgie Farm: The Council had passed motion to reimburse volunteers caring for animals after the farm closed. DH was now in discussions with legal officers about taking this forward. JG noted that many businesses had raised money for the farm and may not now what to do with this money now.  BT Phone Boxes at Co-op: DH is asking to have these removed.  WASP: This used to be a Council building. There are a number of longstanding artists in these studios who have not been told where their new studios will be when the building is sold.  Living Rent: They had been raising awareness about public toilets on Saturday by the phone boxes at the Co-op

There were no further details on what this might be for but it was noted that the shop has started selling samosas.
